# **PROJECT GOALS:**

- Bring a collections-centered approach to OHS's planning efforts
- Assess condition of collection
- Ensure OHS collections practices are in line with those of other local historical societies as well as new trends in collections management
- Assess how OHS buildings are serving the collections and what kind of improvements might be needed
- Make realistic and executable recommendations for moving forward

# **5 COLLECTIONS TIERS**



# TIER 1

- very significant to Oysterponds
- tells multiple Oysterponds stories
- well documented
- rare or irreplaceable
- example: William Steeple Davis Photographs

## TIER 5

- limited or no historical value
- limited or no documentation
- plays very minor role in Oysterponds story
- example: nutmeg grater from Oysterponds family



#### **OLD OHS COLLECTING SCOPE:**

- anything related to Oysterponds
- items from outside the Oysterponds geographic area if they are useful for research or comparison



#### **NEW OHS COLLECTING SCOPE:**

- Belonging: how we claimed "this secluded place," and how it in turn claimed us
- What it means to live close to the land and the sea
- The patterns and rituals of our community
- Our families: the old families, the new families, "families of choice"
- Institutions and activities that are the social glue of our community
- Our special places
- Community inflection points: change and resistance to change, efforts to protect Oysterponds
- Our creative spirit, whether professional or amateur
- Our stories: accounts that show a distinctively Oysterponds perspective on the world



#### **OHS DOES NOT COLLECT:**

- Objects that represent regional or national histories but have no specific tie to Oysterponds
- Objects with no documentation and/or no local story
- Duplicates of existing collections items



# **GUIDING PRINCIPLES:**

- OHS has different types of collections with different needs and levels of importance.
- The buildings & grounds are part of OHS's collection.
- The collections must be relevant to Oysterponds residents or there's no point.
- OHS needs a healthy balance of preservation and access.
- Risk can't be eliminated but it can be managed.
- The collections can't come at the expense of organizational capacity & sustainability.
- Healthy collections need regular weeding.
- Not every object is worth its preservation cost.
- Collections planning must account for climate change.



# WHAT DOES OHS NEED TO DO?

- 1. Address any active deterioration of buildings and collection items
- 2. Address any high risks of future damage or improvements that would have an outsized effect on Oysterponds community or organizational sustainability
- 3. Any reasonable additional measures to reduce risk without burdening organizational capacity



## **KEY PRIORITIES:**


- Protect the collection from moisture
- Put the archives collection (photographs, manuscripts, and other paper records) first in line for preservation and resources
- Weed out collections items that have little to no meaning for residents



## **OTHER MEASURES:**

- Keep collections

   (particularly Tiers 1-3) out
   of basements and attics
   wherever possible
- Pursue fire suppression & compact shelving as appropriate
- Move staff to Vail House
- Consider an addition on Vail House for collections storage
